I N F O R M A T I O N

The undersigned Prosecutor accuses **RUSTOM SIMBULAN @ KA BOBBY @ KA BAYANI @ KA SILANG @ KA ARTHUR and JOHN DOES**, of Puerto Galera, Oriental Mindoro, with the crime of **MULTIPLE MURDER and MULTIPLE FRUSTRATED MURDER**, committed as follows:

That on or about the 3rd day of March 2006, at around 5:00 o'clock in the morning, more or less, at Barangay San Isidro, Municipality of Puerto Galera, Province of Oriental Mindoro, Philippines, and within the jurisdiction of this Honorable Court, the above-named accused, conspiring, confederating and mutually helping one another, with decided purpose to kill and while armed with unlicensed firearms of different caliber, did then and there wilfully, unlawfully and feloniously attack, assault and shoot **P/Insp Wilson Gani, PO2 Dondon Pangilinan, PO1 Joseph Panes, PO1 Roderick Padojinog, PO1 Amor Mio Baticos and Leonardo Canbe**, who were then unaware, inflicting upon **PO1 Roderick Padojinog, PO1 Amor Mio Baticos and Leonardo Canbe** mortal wounds in the different parts of their body, which caused their instantaneous death; and inflicting upon **P/Insp Wilson Gani, PO2 Dondon Pangilinan and PO1 Joseph Panes** multiple injuries thus performing all the acts of execution which would produce the crime of murder as a consequence, but which nevertheless did not produce it by reason of causes independent of the will of the accused, and that is by the timely and able medical treatment rendered to the said **P/Insp Wilson Gani, PO2 Dondon Pangilinan and PO1 Joseph Panes** which prevented their death.


That in the commission of the crime, the qualifying circumstances of use of unlicensed firearms, treachery and evident premeditation and the aggravating circumstance of abuse of superior strength are attendant.
